MGRM would like invite potential suppliers to submit bids for the provision of HIV HOME SELF-TEST KITS, under the following conditions.

GENERAL CONDITIONS

Once submitted, the bidder accepts in full and in its entirety, the content of its bidding document. No reservations or conditions may be tied to the bid submitted.

Clarifications could be sought by the supplier, if necessary, by writing to MGRM on e-mail mgrm@maltagayrights.org by the date indicated in the call. All responses to clarifications would be posted on the MGRM website for perusal by all potential bidders.

Prospective suppliers must submit their bid to this expression of interest online by writing to e-mail mgrm@maltagayrights.org by the closing date and time indicated in the Expression of Interest. Late submissions will not be accepted.

All importation documentation/import formalities to be completed by winning bidder.

All prices and submitted documentation are to remain valid for a period of 12 months from date of submission.

TECHNICAL SPECIFICATIONS

Complete Self Determination of HIV status in a home (non-clinical) setting

C.E. mark specifically for HIV self-testing and not For Professional Use Only

Test for HIV1 and HIV2 antibodies.

Complete system for home self-testing including (but not limited to):

- HIV Self-Test Device
- Single-Use Safety Lancet
- Plaster
- Test Guide
- Result Guide
- Disposal Bag

High sensitivity and high specificity (>99%) (with a 3 month post exposure window)

Clear instruction leaflet(s) for use and for result included with each kit in the English Language.

Quantity: 250 kits initially, with option for repeat orders of 250 at a time (same price/tender terms)

EXPRESSION OF INTEREST SUBMISSION

The bid needs to contain:

1. The unit price of each kit, inclusive of all taxes and VAT. A breakdown showing the components of the unit price must also be given
2. The total price for each order of 250 kits, inclusive of all taxes and VAT, and inclusive of volume discounts (if applicable), and to include delivery to MGRM offices (address in Malta will be supplied to winning bidder)
3. Full technical specifications, including all relevant technical and scientific literature
4. Regulatory documentation, including details of registration of product with local and European authorities

CRITERIA FOR AWARD

The expression of interest will be adjudicated on the basis of price. The contract will be awarded to the cheapest priced bid satisfying the general administrative and technical criteria. MGRM retain the right to reject any or all tender submissions.
